In the <b>regular</b> approval process, grant decisions are made twice annually—in Spring and Fall—by the Board of Directors. Applicants are informed of the funding decision shortly thereafter. The <b>expedited approval process</b> allows grants to be dispersed between Board meetings, and decisions are made by the Board's Grantmaking Committee. This track is used to ensure timely responses to projects that take advantage of new openings or developments in the region. Decisions are made within one month by the Grantmaking Committee. The <b>urgent approval process</b> is to respond quickly to short-lived or emergency opportunities that require an immediate intervention. The Fund will only consider requests for \$5,000 or
	below. Decisions are made within one week by the Board Chair and the Executive Director."
